
The TC74LCX86 is a high-performance CMOS exclusive OR gate. Designed for use in 3.3-V systems, it achieves high-speed operation while maintaining the CMOS low power dissipation.

The device is designed for low-voltage (3.3 V) VCC applications, but it could be used to interface to 5-V supply environment for inputs

All inputs are equipped with protection circuits against static discharge.





AC Waveform





